

Participant Agreement, Waiver & Release of Liability

Registration acknowledgment

By checking the box below and submitting this form, I acknowledge, understand, and agree to the following:

1) Compliance with League Policies

I understand that by registering for and participating in **SCSL Pittsburgh, Inc. dba Steel City Softball League** (“the League”), I am expected to uphold the values, policies, and commitments set forth by the organization, including but not limited to:

- The **Ally Pledge**, which affirms my commitment to creating an inclusive and respectful environment for the LGBTQ+ community.
- The **Financial Agreement**, which outlines my responsibility to pay all required fees in full before participating.

I acknowledge that failure to adhere to any of these policies may result in disciplinary action, including suspension or permanent removal from the League, as determined by the Executive Board.

2) Zero-Tolerance Policy & League Safety Commitment

I understand that the League is committed to fostering a safe, welcoming, and inclusive environment for all participants, particularly members of the queer community. To maintain this commitment:

- The League has a **zero-tolerance policy** for discrimination, harassment, bullying, hate speech, or any actions that create an unsafe or hostile environment.
- Any violations of the Ally Pledge, Code of Conduct, or Financial Agreement will be reviewed by the Executive Board, and disciplinary actions—including removal from the League—may be taken without refund.

- The League reserves the right to refuse participation to any individual whose behavior undermines the safety and integrity of the organization.

3) Non-Refundable Fees & Financial Commitment

I understand and agree that:

- All registration fees are **final and non-refundable** once the season begins, regardless of my participation status, injury, removal, suspension, or withdrawal.
- I am required to **pay in full before participating**, in compliance with the League's financial policies.
- No refunds will be issued due to weather cancellations, schedule changes, or other unforeseen circumstances affecting gameplay.

4) Waiver of Liability & Assumption of Risk

I acknowledge that participation in League events, practices, and games involves inherent risks, including but not limited to physical injury, property damage, and emotional distress. By participating, I:

- Knowingly assume all risks, including those arising from the negligence of the League, its officers, officials, volunteers, sponsors, and affiliated entities (“Releasees”).
- Waive, release, and hold harmless the Releasees from any claims, liabilities, or damages related to my participation, to the fullest extent permitted by law.
- Understand that the League does not provide medical coverage and is not responsible for any medical expenses incurred due to my participation.

5) Agreement & Digital Signature

By checking the box below, I confirm that:

- I have read, understood, and agree to comply with all League policies.
- I acknowledge the zero-tolerance policy and understand that violations may result in removal without refund.
- I accept all financial responsibilities and acknowledge that fees are non-refundable once the season begins.
